

**FIRST ADDENDUM TO PARK-SCHOOL INTERGOVERNMENTAL
AGREEMENT BY AND BETWEEN COMMUNITY UNIT
SCHOOL DISTRICT 200 AND CAROL STREAM PARK DISTRICT**

The Park-School Intergovernmental Agreement entered into by and between COMMUNITY UNIT SCHOOL DISTRICT 200 ("CUSD 200") and CAROL STREAM PARK DISTRICT ("CSPD"), dated June 8, 2010, is hereby amended and modified as follows:

1) In consideration of the mutual interest of CUSD 200 and CSPD to provide additional outdoor play equipment for CUSD 200 and CSPD students and community residents, CUSD 200 agrees that it shall pay all costs of constructing and installing such outdoor play equipment on CSPD property located adjacent to CUSD 200's Pleasant Hill Elementary School and CSPD agrees it shall allow the construction and installation of said equipment on its property by CUSD 200 and its selected contractors.

2) CUSD 200 and CSPD agree that they shall meet and mutually agree upon the location of the equipment, as well as the type of equipment to be installed.

3) Before commencement of the work or delivery of any equipment or materials onto CSPD property, CUSD 200 shall furnish CSPD with plans and specifications, names and addresses of contractors, copies of contracts, necessary permits and indemnification in form and amount satisfactory to CSPD and waivers of lien against any and all claims, costs, damages, liabilities and expenses which may arise in connection with the planned alterations and improvements. CUSD 200 agreed to hold harmless and defend CSPD from and against any and all liabilities of every kind and description which may arise out of or be connected in any way to said alterations and improvements. CUSD 200 shall also furnish CSPD with certificates of insurance from all outside contractors performing labor or furnishing materials that insure CSPD against any and all liabilities which may arise out of or be connected in any way with said alterations and improvements.

4) Following the installation of the outdoor play equipment on CSPD property, CSPD shall be responsible for the subsequent inspection, maintenance and repair of the equipment. CUSD200 also agrees that if at any point that CSPD indicates that the outdoor play equipment has become unsafe and is beyond repair, CUSD 200 will remove or replace the equipment.

5) All other terms and conditions set forth in the Park-School Agreement governing the permitted use of the grounds and facilities of CSPD by CUSD 200 and the permitted use of the grounds and facilities of CUSD 200 by CSPD shall be applicable to the new outdoor playground equipment which is the subject of this Addendum.

IN WITNESS WHEREOF, CUSD 200 and CSPD have caused the First Addendum to Park-School Intergovernmental Agreement to be executed by their duly authorized officials this 18 day of July, 2012.
